

Terms & Conditions for Donations

These rules and regulations ("Terms and Conditions") shall be binding on each Donor who voluntarily desires to make a monetary donation to assist Hamari Laado Foundation ('Foundation') in Indian Rupees.

1. Eligibility

You are eligible to donate if (i) you have attained the age of majority i.e. eighteen (18) years or (ii) you are a company/proprietorship or any other entity duly registered/incorporated under the laws of India.

Payment through online transfer can be made on this website (www.hamarilaado.org) following the instructions therein to make donations upon which the Donor shall be redirected to the payment gateway to complete the donation transaction. Donations received through this payment mechanism shall be directly deposited into the Hamari Laado Foundation bank account.

The Donor shall also be bound by the terms and conditions of the payment gateway service provider while making donations.

For purposes of these Terms and Conditions, "receipt/processing" of a donation occurs when the bank website server records the donation information upon the Donor clicking the "Donate/Submit/Process" button.

Kindly avoid donations of less than Rs.250/- as the processing costs make it unviable for us.

2. Personal Information:

Your donation may result in sharing of your personal information including but not limited to your Name, Phone Number/Email ID, PAN, Credit and/or Debit Card. ([Read Hamari Laado Foundation's Privacy Policy here](#))

3. Tax Deduction Benefit:

Hamari Laado Foundation is incorporated as a 'not for profit' company under section 8 of the Companies Act, 2013 (CIN of the Company is U85200RJ2020NPL069630).

The Foundation has a valid and subsisting registration under Section 80G of the Indian Income Tax Act, 1961.

Donations to the Foundation are eligible for deduction under section 80G of the Indian Income Tax Act, 1961.

4. Cancellation and Refund Policy

We take the utmost care to process donations as per the instructions given by our donors, online and offline. However, in case of an unlikely event of an erroneous donation, we will respond to the donor within 14 working days of receiving a valid request for refund from the donor.

The timely refund of the donation will depend upon the type of credit card/banking instrument used during the transaction. The donor will have to send us a written request for a refund within 2 days of making the donation along with proof of the deduction of the donation amount.

In cases where the donation receipt has already been issued to the donor, the receipt shall stand cancelled, and the Donor must not use it for any purpose whatsoever, except for her/his/their record keeping.

If the tax exemption certificate is already issued, we will not be able to refund the donation. However, in case of a valid refund request due to any error on our part, we will refund the donation and bear the costs of the same.

If the donor doesn't write within two days, then a refund is not possible.
